Scope of Services

The selected provider will be required to deliver the following services for the 2024-25 accounting period initially:

Annual statutory audit in accordance with the Charities Act 2011 and Charities SORP FRS 102 in addition to the relevant accounting and auditing standards, including but not limited to:

- Year-end planning including pre year end meeting
- Key risk identification and mitigation
- Documenting systems in detail and performing walkthrough tests to confirm operations.
- A hybrid approach with the potential for some face-to-face meetings if needed
- Drafting audit report and management controls report
- Attendance as required at Board and sub-committees to report on findings



In addition:

- Production of year-end financial statements
- The production of corporation tax, capital allowance computations and form CT600 annually.

Additional advice / services to be made available including

- Advice on taxation matters
- Accounting and payroll query support

A key contact to provide support throughout the year for ad hoc queries related to finance and audit processes.

Scoring Criteria for Audit Services Tender

To ensure a transparent and objective evaluation process, we will use the following scoring criteria for assessing tender submissions. Each section of the proposal will be evaluated based on clear metrics and assigned a score. The total score will determine the selection of the most suitable consultant.

Total Score: 100

Approach and Methodology (15 points)

- Detailed and clear approach: 15 points
- General approach with some customization: 8-14 points
- Broad or vague approach without specifics: 0-7 points

Timeline (10 points)

- Clear and realistic timeline with defined milestones: 10 points
- Adequate timeline with some milestones: 5-9 points
- Unclear or unrealistic timeline with few or no milestones: 0-4 points

Proven experience in delivering audit and taxation services within the non-profit or public sectors (10 points)

- Comprehensive experience with similar organizations: 10 points
- Partial or related experience: 5-9 points
- Limited or no relevant experience: 0-4 points

Demonstrable experience of working with Active Partnerships (10 points)

- Comprehensive experience: 10 points
- Partial or related experience: 5-9 points
- Limited or no relevant experience: 0-4 points

Accredited Auditing qualifications (5 points)

- Full accreditation 5 points
- Partial or pending accreditation: 1-4 points
- No accreditation: 0 points

Strong track record of working with similar organisations to facilitate a smooth and well administered audit process (5 points)

- Demonstrated impact with measurable outcomes: 5 points
- Anecdotal evidence without clear metrics: 1-4 points
- No track record provided: 0 points



Ability to provide ad hoc support throughout the year above and beyond the standard audit process: (15 points)

- Clear offer to provide ad hoc support 15 points
- Partial availability to provide support: 8-14 points
- Minimal opportunity for ad hoc support: 0-7 points

Detailed breakdown showing excellent value for money: (15 points)

- Adequate breakdown with reasonable value: 8-14 points
- Poor breakdown or not justifying the cost: 0-7 points

References from previous clients (15 points)

- Excellent feedback with strong recommendations: 15 points
- Good feedback with minor reservations: 7-14points
- Mixed or poor feedback: 0-4 points

Proposals will be evaluated based on the above criteria. Submissions may be shortlisted and applicants may be invited to a clarification interview. In the event of a tie, the proposal that demonstrates the greatest alignment with Together Active's mission and strategic goals will be prioritised
